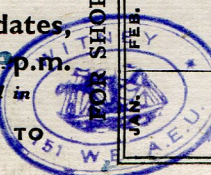

INDUSTRIAL MEMBER

A member's card shall stand as a statement of contributions paid, but the member shall be held responsible for its regular presentation. In no case shall arrears improperly computed affect the correct financial position of the member. (See Rule 27, Clause 8.) If not produced in case of dispute, the Union's books must decide.

The number of days exempt from the payment of contributions by causes stated in Rule 27, Clause 5, must be inserted on this card in the quarter they occur.

Members having money to refund must do so from their own means, before receiving benefit.

All members are disqualified from receiving benefit if they neglect to pay in conformity with Rule 27. Members eight weeks or more in arrears must reduce them below that amount and keep same below for four weeks before being entitled to benefit. Those members whose arrears exceed 18 weeks' contributions are due for expulsion.

The date marked thus (*) is for the Annual Election of Officers.

Members are requested to use every exertion to obtain work for our unemployed, and so lighten the burden of all.

Any member commencing work shall, in writing, inform his Secretary from his own, shall also inform the nearest Secretary within the same period within 48 hours of starting, and if such work is in another district apart and also give his rate of pay within three days of receiving same, or be fined 1s. No Secretary is allowed, under penalty of 5s., to receive members' contributions out of branch meeting, except sea-going members, and such as are remitted by post, which shall be paid into the branch on the next meeting night, such sums to be then inserted on the member's card. Any member, or person acting on behalf of a member, disregarding these instructions, shall be responsible for such neglect. The Union accepts no responsibility for contributions paid in contravention of Rule 7, Clause 12. Postal Orders sent in payment of contributions must be sent to the Branch Secretary and crossed thus / / and made payable to Amalgamated Engineering Union. Members wishing their cards returned by post should enclose a stamped addressed envelope.
